

IOSS restricted HS Tariff Codes to Ireland

November 2021

November changes highlighted below

If you are sending a globalpriority, globalvalue or euroeconomy item to Ireland via the Import One Stop Shop (IOSS) VAT scheme, with an HS code where the first 6 digits relate to a chapter or heading in the table below, are restricted by Irish Customs and will be returned to sender.

Exceptions to these restricted codes have been added in the final column.

To send Import One Stop Shop (IOSS) items to Ireland that are in the table below, we recommend using our europriority service. This requires more information to be provided so that your item can be cleared successfully such as a 10 digit HS code.
